## 2020 Impact Report

Thanks to the support of our generous donors, the Ottawa County Parks Foundation enjoyed a successful 2020. It was not the year any of us expected, yet Ottawa County Parks saw record attendance as people flocked to outdoor spaces for their physical and mental well-being. The Foundation committed funds to several key Parks projects.

Your support made possible:

- Funding for the multi-year Grand River Greenway Campaign, leading to trail construction along 12th Avenue in Georgetown Township;
- Additional property purchased in the Bend Area, now totaling 421 acres;
- Final design and engineering plans for the Stearns Connector, Eastmanville Connector, Bass River, and Jenison Mill segments;
- Designation of \$10,500 for the Ottawa Sands master plan and natural features inventory;
- Thanks to an anonymous foundation, a Treehouse overlook at Grand Ravines North will be constructed. Construction is expected to begin later this year.
